PAYMENT

In order to reserve the date and time indicated above, I understand and by my signature on this Contract, hereby agree to the following terms:

- This Golf Event Contract must be signed with a 25% DEPOSIT to formally secure the requested outing date. This Deposit can be paid with cash, corporate check, or credit card. (NOTE: This deposit will be applied toward the final bill.) **Initial**_____
- The FINAL COUNT for all golfers, including all outing volunteers, must be provided **14 days** prior to the event date. **Initial**_____
- The FINAL BALANCE must be paid in full no later than the end of the day on the event date. This amount can be paid with cash, corporate check, or credit card. **Initial**_____
- PAIRING / TEAM LIST: A pairing list / team list must be emailed to the Event and Outing Coordinator no later than **seven days** prior to your Golf Outing Date. events@thelinksatheartlandcrossing.com

INCLEMENT WEATHER

Outings at The Links at Heartland Crossing will take place rain or shine. We will do our best to complete the outing on the scheduled date. If The Links at Heartland Crossing has to close the course due to unplayable course conditions or inclement weather a “rain date” can be discussed at that time.

SIGNAGE / SPONSOR FLAGS

The Links at Heartland Crossing staff will place and remove all signage and sponsor flags utilized by the tournament at no extra cost. Signage must be delivered at least 3 days prior to the day of the event. Signage must be claimed by each event and removed from the property at the conclusion of the event. After 72 hours, all signage left behind will be discarded. Sponsor flags will be placed at random unless directed differently by the Event Coordinator. A flag placement list must be provided at least 1 day prior to the day of the event.

CANCELLATION POLICY

The Links at Heartland Crossing prides itself in planning and facilitating professional events for all groups. In most cases, our staff maintains schedules well in advance of association or group commitment dates. In the event of a cancellation, it is unlikely another group can fulfill these dates, especially if canceled close to the actual event date. To partially recognize lost time, it is agreed the following terms will be enforced:

Cancellation within 60 days of the event – 0% of program fee will be forfeited

Cancellation within 30-60 days of the event 50% of program fee will be forfeited

Cancellation within 29 days or less of even – 100% of program fee will be forfeited

NOTE: The above terms will apply to CANCELED events only, not to RESCHEDULED events.

It is the sole discretion of The Links at Heartland Crossing to determine if the weather is cause for cancellation on the day of the event. If, in our opinion, an event must be canceled you will have the option to schedule another day. Once an event begins, there will be no refunds unless the course is closed by the officials on site. **Initial** _____

INDEMNIFICATION

Client hereby jointly and severally agrees to indemnify, defend and hold The Links at Heartland Crossing harmless from all claims, suits, actions at law, judgments, liabilities, losses, and damages (including attorney’s fees) arising from the use of The Links at Heartland Crossing property, however caused, including without limitation, any injury or damages resulting from negligent, careless, improper or unlawful conduct. **Initial** _____

DAMAGES

We agree to exercise extreme caution when operating equipment (specifically but not limited to golf carts) and utilizing the golf course property. In the event that we cause damage to the property and/or equipment used by our participants, we agree to pay in full for any and all damages. **Initial** _____

CONDITIONS OF THE AGREEMENT

Performance of the agreement is contingent upon the ability of The Links at Heartland Crossing management to complete the same and is voidable in the event of labor disputes or strikes, accidents, government (Federal, State, or Municipal) requisitions, restrictions on travel, transportation, food, beverages, or supplies, and or other causes, whether enumerated herein or not, beyond the control of The Links at Heartland Crossing preventing or interfering with the delivery of services required for the private function. In no event shall The Links at Heartland Crossing be held liable for other damages.

Note that The Links at Heartland Crossing shall retain complete control of golf operations on outing days.
